- ALL PARTS USED TO SERVICE, REPAIR, OVERHAUL OR SOLD OUTRIGHT REMAIN THE PROPERTY OF G-SQUARED UNTIL GOODS HAVE BEEN PAID FOR IN FULL.
- THE PRICE AND DELIVERY QUOTED APPLIES AT THE TIME OF QUOTATION AND IS SUBJECT TO SUPPLIER STOCK REMAINING UNSOLD AT THE TIME OF OUR ORDER.
- QUOTATION ESTIMATED COSTS EXCLUDE V.A.T UNLESS STATED.
- ANY DELAY IN ACCEPTING A QUOTATION MAY AFFECT PRICE AND DELIVERY.
- ALL WORK IS SUBJECT TO SATISFACTORY TESTS BEING COMPLETED, WHERE A UNIT FAILS TEST AND REQUIRES FURTHER WORK TIME A REQUOTE WILL BE SUBMITTED TO THE 'BUYER'.
- AN INSPECTION CHARGE AS STATED ON THE QUOTE MAY APPLY IF THE ESTIMATED COSTS ARE NOT ACCEPTED TO COVER INSPECTION AND QUOTATION TIME AND ENVIRONMENTAL DISPOSAL OF GOODS WHERE APPLICABLE.
- IF THE QUOTATION IS NOT APPROVED WITHIN THE STATED VALIDATION DATE G-SQUARED AVIATION RESERVES THE RIGHT TO RETURN THE GOODS AT THE ABOVE COSTS TO DATE PLUS CARRIAGE.
- PAYMENT TERMS ARE 30 DAYS NETT - UNLESS OTHERWISE STATED. ACCOUNTS OF 'BUYERS' WHICH EXCEED THESE TERMS MAY BE PUT ON 'STOP' AND CONTINUAL MISUSE WILL LEAD TO A PRO-FORMA ACCOUNT SITUATION.
- SHORTAGES AND DAMAGES IN DELIVERY SHOULD BE NOTIFIED TO US IMMEDIATELY AND IN ANY CASE WITHIN 3 DAYS IN WRITING.
- QUOTATIONS ARE VALID FOR 30 DAYS UNLESS OTHERWISE STATED IN THE QUOTATION.
- NO AMENDMENTS TO ANY ORDER CAN BE MADE BY THE 'BUYER' WITHOUT THE 'SELLERS' PRIOR WRITTEN CONSENT.
- THE QUOTE PRICE IS CONFIDENTIAL INFORMATION AND SHALL NOT BE DISCLOSED TO ANY THIRD PARTY.
- THE SELLER RESERVES THE RIGHT AT ANY TIME TO DEMAND FULL OR PART PAYMENT ON ANY ORDER BEFORE PROCEEDING FURTHER WITH AN ORDER.
- IF BUYER COMMITS ANY DEFAULTS, WHICH GENERALLY MEANS ANY FAILURE TO PAY THE SELLER ON THE DUE DATE ACCORDING TO THE PAYMENT TERMS, THE APPOINTMENT OF A RECEIVER, OR A PROVISIONAL LIQUIDATOR OR A LIQUIDATOR SELLER SHALL BE ENTITLED FORTHWITH TO RECOVER AND RESELL ANY OR ALL OF SUCH GOODS AND IN ADDITION ALL OTHER GOODS AGREED TO BE SOLD BY THE SELLER. FOR SUCH PURPOSE THE SELLER SHALL HAVE AN IRREVOCABLE LICENCE OR AUTHORITY TO ENTER ANY PREMISES WHERE THOSE GOODS MAY BE SITUATED.
- CANCELLATION OF ORDERS-NO ORDER WHICH HAS BEEN ACCEPTED BY THE SELLER CAN BE CANCELLED WITHOUT WRITTEN AUTHORITY OF THE SELLER. THE SELLER RESERVES THE RIGHT TO CHARGE A RESTOCKING FEE AND ANY COSTS INCURRED.
- UNLESS OTHERWISE AGREED IN WRITING ANY DELIVERY DATE OR PERIOD SPECIFIED BY THE SELLER IS AN ESTIMATE ONLY AND TIME OF DELIVERY IS NOT THE ESSENCE OF THE CONTRACT. THE SELLER SHALL NOT BE LIABLE FOR ANY LOSS OR DAMAGE SUSTAINED BY THE BUYER AS A RESULT OF LATE DELIVERY.
- THE BUYER SHALL BE SOLELY RESPONSIBLE FOR THE OBTAINING OF ANY NECESSARY TRANSPORT LICENCES, PERMISSIONS OR AUTHORISATIONS IN RESPECT OF THE GOODS AND THE SELLER SHALL UNDER NO LIABILITY WHATSOEVER IN RESPECT OF GOODS EXPORTED WITHOUT THE NECESSARY LICENCES, PERMISSIONS OR AUTHORISATIONS.
- THESE CONDITIONS SHALL BE GOVERNED BY THE LAW OF ENGLAND.
